They say that creating children for same-sex couples is not wanting the best for a child because it breaks biological relationships and steals their identity.



Heather Barwick is a former gay-marriage advocate turned activist for children's rights. She was raised by her mother and her mother's lesbian partner.

"Dear Gay Community ... a lot of your kids, are hurting."

"Same-sex marriage and parenting withholds either a mother or father from a child while telling him or her that it doesn't matter. That it's all the same. But it's not."

"My father's absence created a huge hole in me, and I ached every day for a dad."

"I loved my mom's partner, but another mom could never have replaced the father I lost."

"Gay marriage doesn't just redefine marriage, but also parenting. It promotes and normalizes a family structure that necessarily denies us something precious and foundational."

Robert Oscar Lopez is assistant professor of English at California State University, Northridge. He was raised by his lesbian/bisexual mother and her female partner from the age of two.

Australians want children raised by their biological parents – latest poll

To all four questions by a margin of three-to-one:

- Australians agree we should try to ensure that children, where possible, are raised by their own mother and father.
- Australians agree that the right to marry includes the right to create a family.
- Australians think it is more important that a child should have a mum and dad than that two men should have the right to marry and create a family.
- Coalition voters would be “MUCH LESS likely” to vote for an MP who supports same-sex marriage.

This diagram from "LGBT rights in Australia" (below) shows that the same-sex marriage lobby wants more than just weddings to express their affection for each other.

...so marriage is not just about "LOVE"

They want:

- **biological parents removed** from the child's birth certificates and replaced with the names of the same-sex parents.
- **children** by surrogacy, artificial insemination and adoption.

Marriage means mum/dad/children

Same-sex couples cannot naturally have children. They can only have children by breaking the deep biological relationships between children and their biological mother and father, their biological brothers, sisters and grandparents. This means that many children conceived for gay couples cannot know their full family medical history, or their full identity.

- "Gay Dads in Australia" advises same-sex male partners on how to set about obtaining children by surrogacy. It says, "in California for example, you can get a pre-birth judgment placing both dads on the birth certificate." www.gaydadsaustralia.com/surrogacy/

What about the rights of children to a relationship with their biological family and to know their identity?

Three separate inquiries, by the Federal Senate, the NSW and Victorian parliaments, expressed concern at the failure of the law to protect the relationship of donor conceived children with their biological father/mother. These inquiries were demanded by children wanting to find their **biological family** and know their **full biological identity**.

So why would the Federal government pass a same-sex marriage law that will encourage more broken relationships between children and their biological family?

Politicians must oppose same-sex marriage so as to protect the rights of children to their biological family relationships and to their full identity.
